

# PERPETUAL IMPORTANT UPDATE

18 June 2021

We are writing to you to notify you that we need to delay unit pricing for a number of Funds and Investment options whilst we undertake an assessment of a large application. The reason for delaying the unit price is to consider the requirement for the Funds to pay a special distribution, to ensure we are acting in the best interest of the members.

If special distribution payments are required, these will provide existing investors of impacted Funds with their share of accrued income prior to the large application being processed. This will ensure existing investors are not disadvantaged by the large transaction diluting their accrued income entitlements.

Where a special distribution is determined and paid, there is a possibility there will be no distribution for the period ended 30 June 2021. Perpetual will assess the position of the Fund and consider making another distribution payment for the period ended 30 June 2021 if required.

Any distribution payments to investors will be shown in a distribution statement sent to them. Any special distribution amount paid will also be included in the annual tax statement sent to investors for the 2021 financial year.
