About this document

Target market statement

The Perpetual Pure Credit Alpha Fund - Class W (Fund) is designed for consumers who:

- · are seeking income distribution and capital preservation,
- are intending to use the Fund as a core, minor or satellite allocation within a portfolio,
- · have a minimum investment timeframe of 3 years or longer,
- have a medium to high risk and return profile, and
- are unlikely to need to access their capital within one month of request.

Investment products and diversification

This TMD uses the Standard Risk Measure (SRM) to estimate the likely number of negative annual returns for this product	
over a 20 year period, using the guidance and methodology outlined in the Standard Risk Measure Guidance Paper For	
Trustees (note the bands in the SRM guidance differ from the bands used in this TMD). However, the SRM is not a complete	
assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative	
return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to	
meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example,	
some products may have other risk factors which result from, for example, the use of leverage, derivatives or short selling,	
liquidity or withdrawal limitations, may have underlying investments with valuation risks or risks of capital loss; or otherwise
