## FUND BENEFITS

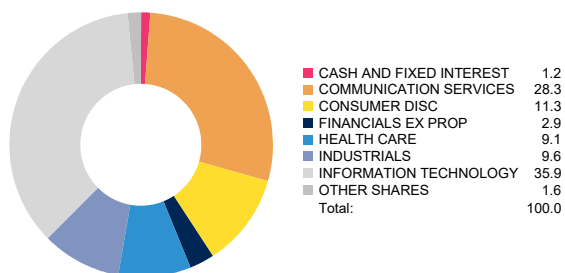

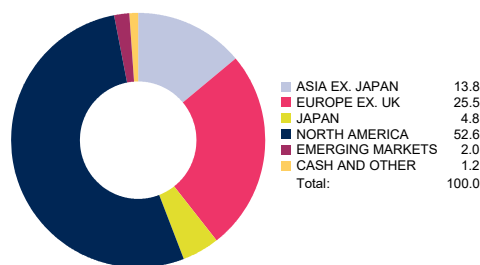
