

## 2025 Miles Franklin Literary Award shortlist revealed

Three first-time nominees are among the six talented writers shortlisted for the 2025 Miles Franklin Literary Award. They are joined by two previously shortlisted authors and a two-time winner.

Announced today by Perpetual as Trustee, alongside Copyright Agency's Cultural Fund, the 2025 shortlist is

Ghost Cities by Siang Lu (University of Queensland Press)

Highway 13 by Fiona McFarlane (Allen & Unwin)

According to the judges, "The shortlist for the 2025 Miles Franklin Literary Award celebrates writing that refuses to compromise. Each of these works vitalises the form of the novel and invents new languages for the Australian experience."

The 2025 judging panel comprises Richard Neville, Mitchell Librarian of the State Library of NSW and Chair; literary scholar, A/Prof Jumana Bayeh; literary scholar and translator, Dr Mridula Nath Chakraborty; literary scholar and author Prof Tony Hughes-d'Aeth; and author and literary scholar, Prof Hsu-Ming Teo.

Each shortlisted author receives \$5,000 from the Copyright Agency's Cultural Fund.

The 2025 winner, announced on 24 July 2025, will receive \$60,000.
