INVESTMENT FEE AND INDIRECT COSTS FOR THE FINANCIAL YEAR ENDED 30 JUNE 2018

The investment fee and indirect costs shown in the current Product Disclosure Statement issue number 10 dated 1 May 2017 (PDS) are estimated amounts. The indirect costs in the PDS are based on the financial year ended 30 June 2016, being the previously completed financial year as at the date of the PDS. The following table provides details of the investment fee and indirect costs based on the latest completed financial year ended 30 June 2018, which may vary in future years.
